This limit applies separately to Building

and Business Personal Property, with an increase of 30 days for the period of restoration available if Business Income and Extra Expense is covered.

Additionally, any expenses to attain a pre-loss level of green building certification from a recognized Green Authority is covered up to \$25,000, subject to five percent of the sum of the amount paid for covered direct damage loss to the building (including any amount paid under the Green Building Alternatives – Increased Cost Additional Coverage) plus the deductible amount applied.
